EXHIBIT A: Terms and Conditions

- 1. Venue and Open19 rules.** Participant must abide by all reasonable rules communicated by the venue managers or by Open19 in connection with attendance at the event.
- 2. Publicity.** Open19 or its agents may take photos or audio or video recordings of individual representatives of Participant at the event. On behalf of such individuals, Participant grants Open19 the right to use such photos or recordings, which may include personally-identifiable information, for any reasonable purpose associated with advancing Open19's mission. Open19 will honor requests to opt out of such use, as reasonably possible.
- 3. Payments.** Any payments due to Open19 in connection with the event must be paid no later than within 30 days of the date of a timely invoice.
- 4. Discretionary refunds.** Open19 will have no obligation to make any refunds of payments received in connection with the event. Open19 may offer refunds in its sole discretion.
- 5. Equipment.** Participant will be solely responsible for all equipment it brings to the event. All risk of loss or damage is borne by the Participant.
- 6. Costs.** Participant bears all of their own costs associated with participation in the event.
- 7. Liability limitation.** Open19's entire liability for damages to Participant in connection with the event will be limited to the amount of fees paid by the Participant for the event. Open19 WILL HAVE NO LIABILITY WHATSOEVER FOR ANY INDIRECT, INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES, WHETHER ARISING IN CONTRACT, TORT, OR ANY OTHER LEGAL THEORY.
- 8. Indemnity.** Participant shall indemnify, hold harmless and defend Open19 and its directors, officers, employees and agents from and against all third party claims, demands, actions, suits, damages, liabilities, losses, settlements, judgments, costs and expenses (including but not limited to reasonable attorney's fees and costs), which arise out of or relate to (a) a negligent act or omission of Participant in connection with the event, (b) infringement of third party intellectual property by that Participant in connection with the event, (c) Participant's failure to comply with reasonable event rules communicated to that Participant.
- 9. Dispute resolution.** These terms, and any dispute arising out of participation in the event, shall be governed, construed and enforced in accordance with the substantive laws of the State of California, USA. Any dispute which is not settled by negotiation within sixty days shall be determined exclusively by arbitration in accordance with the International Arbitration Rules of the American Arbitration Association.
- 10. Entire agreement.** These terms constitute the entire agreement and understanding between Open19 and the Participant with respect to their subject matter.
